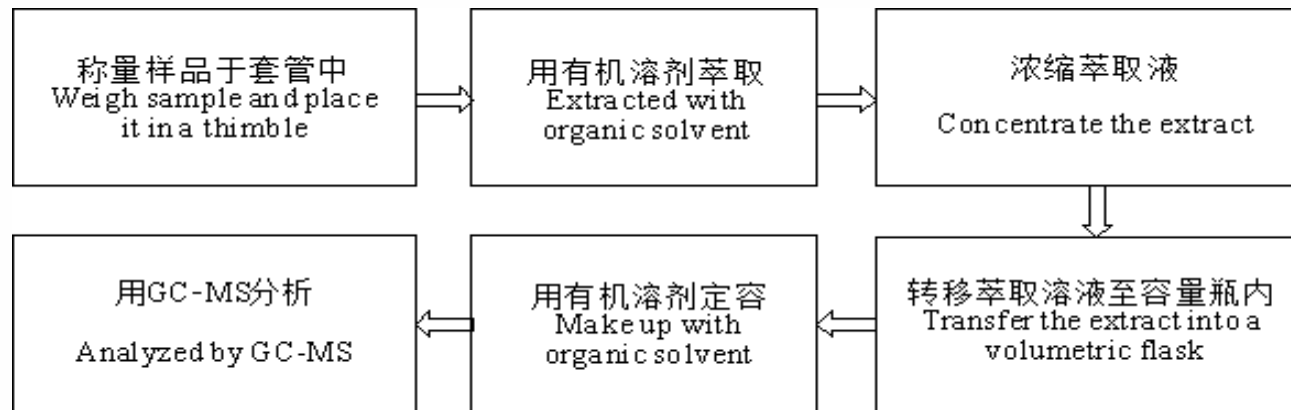

检测流程 Test Process

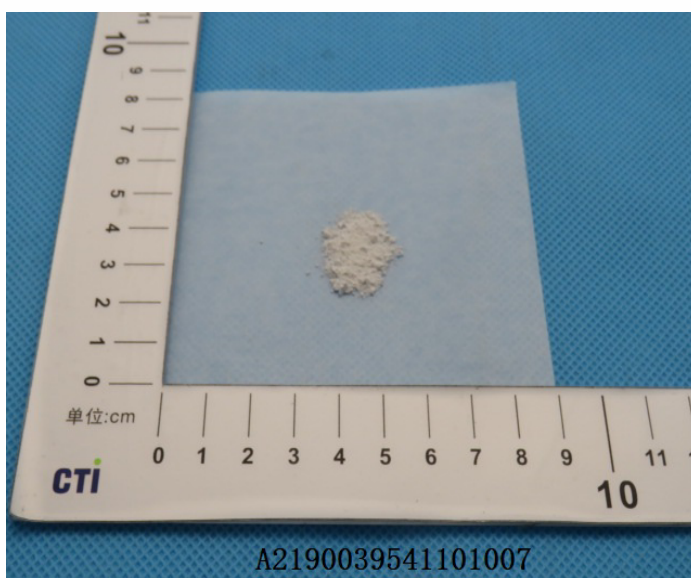
